

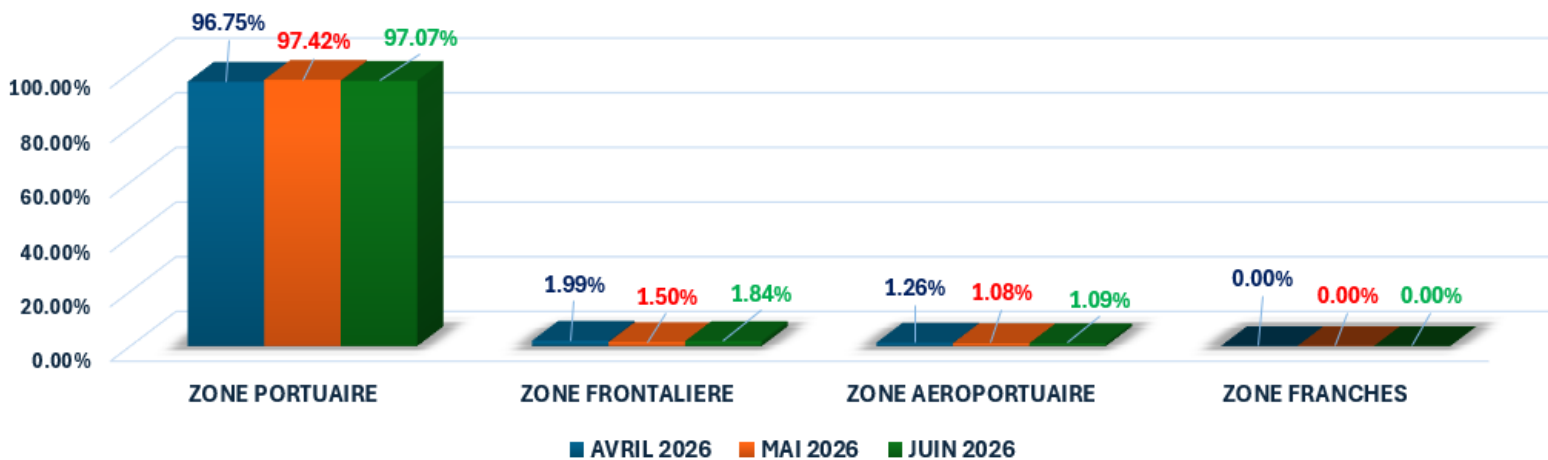

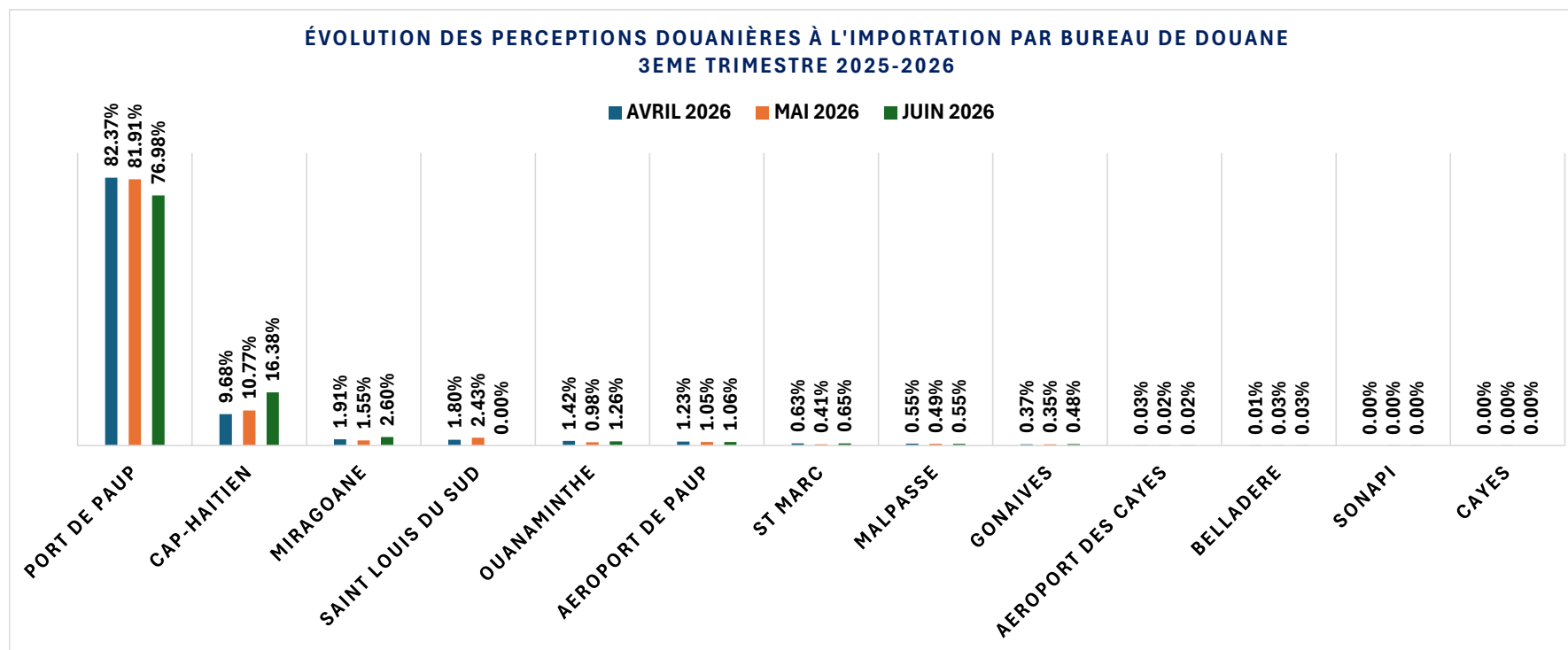

3EME TRIMESTRE 2025-2026**



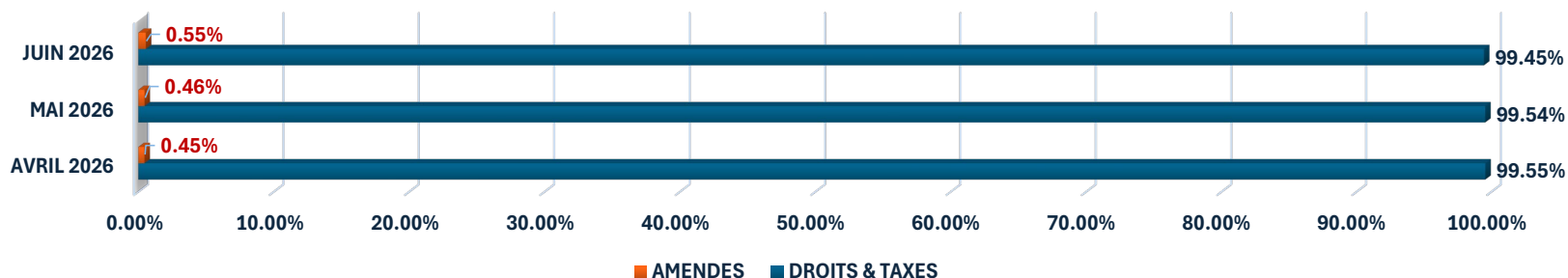

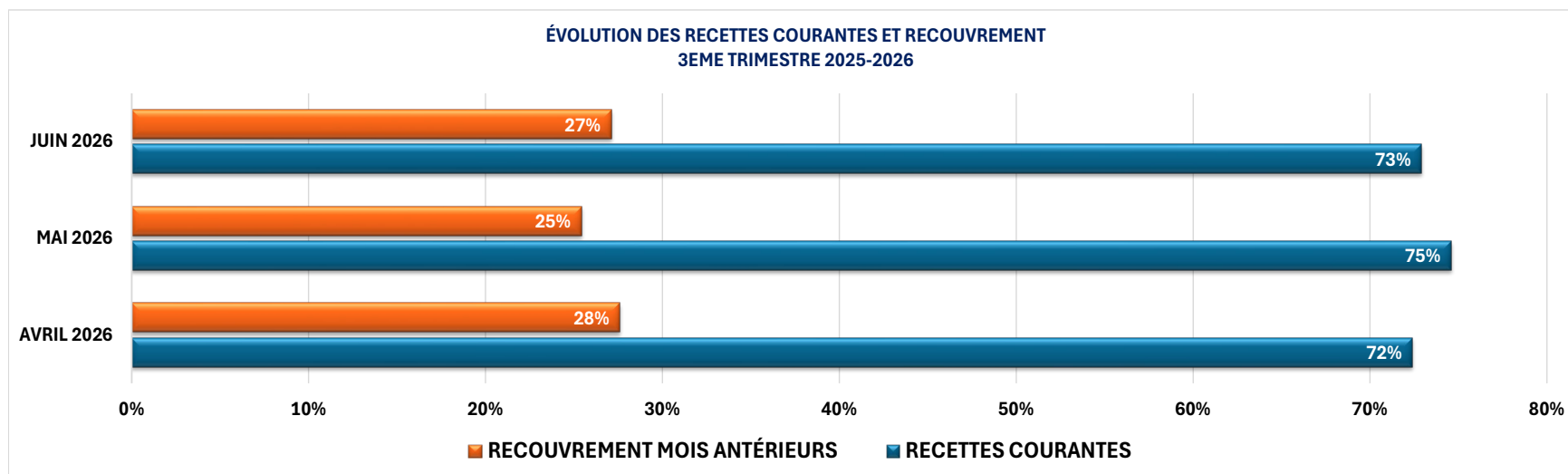

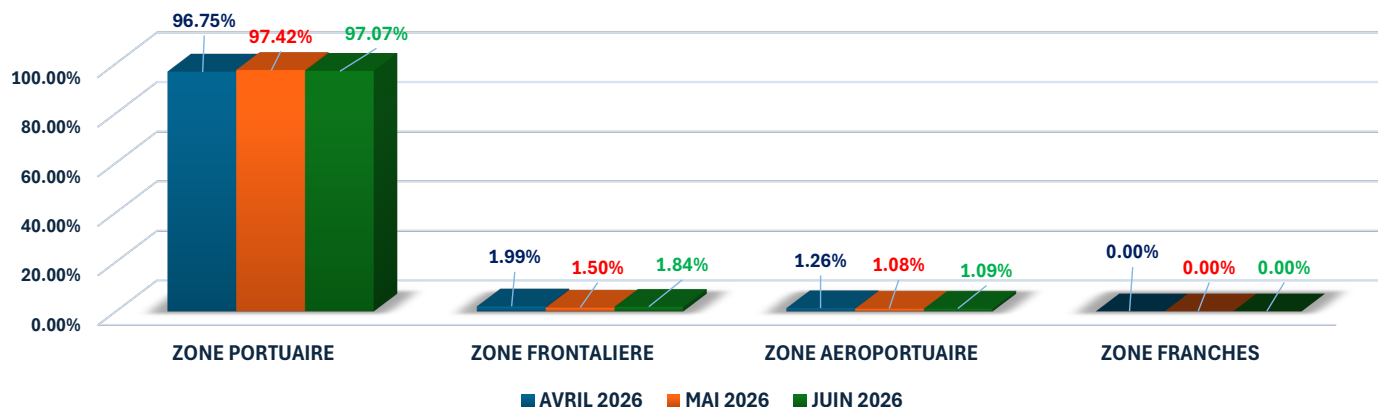
